#### Alternative Tax Bases

§ 1. There are a variety of ways in which value, income, wealth, and profits may be determined. However, the primary tax base used in Canada is the individual's taxable income. This base is the "amount" and is a legal concept, not a common sense one. It differs from common sense in that it is not subjective and is not based on what the taxpayer believes.

**Income tax** is levied on the amount of income earned during the year.

**Capital tax** is levied on the amount of net worth (assets minus liabilities).

Although the 2 countries in which individuals are taxed, property taxes are levied on the value of the property.

When a taxpayer is liable for income tax, the amount of tax is based on the taxpayer's taxable income. This is the amount of income that is subject to tax.

**Gifts** or transfers made to tax exempt or the children or grandchildren of certain persons are taxed.

**Transfer tax** is levied on the transfer of property to a person other than the donor.

**Gift tax** is levied on the gift of property to a person other than the donor.

**Estate tax** is levied on the estate of a person who has died.

**Real tax** is levied on the value of real property owned by a person.
